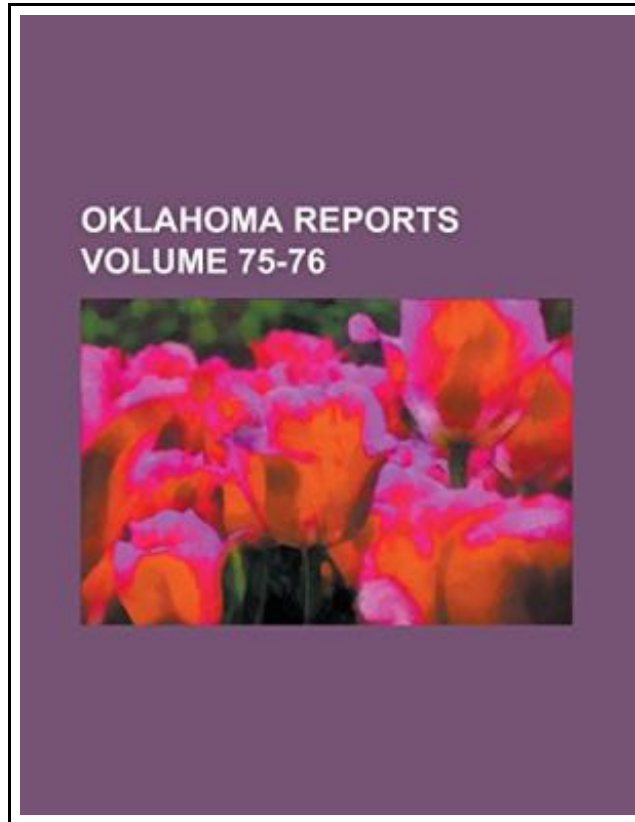

In the *Homesteaders* case jurisdiction was denied on the ground that the question involved was not publici juris. In the *Cobb* case it was held that the question of removal of a county judge for misconduct and malfeasance in office presented such a situation as authorized the court in assuming jurisdiction.
